On a motion by Jack Baker and seconded by Brian Anton it was approved to purchase the 2014 Dodge Charger and to not spend more than the budgeted amount of \$33,000.00. Motion carried with all members present voting aye.

CONSERVATION F900 TRUCK DISCUSSION

Fire Chief Nathan Bower explained that the fire department got the F900 truck from the conservation department and would be costly to put into service. Central Taney County Fire Department is interested in the truck. The conservation department has agreed to allow Forsyth Fire Department to transfer the truck to Central Taney County Fire Department.

On a motion by Clint Hilliard and seconded by Jack Baker it was approved to transfer the F900 truck to Central Taney County Fire Department. Motion carried with all members present voting aye.

FIRE STATION 2 LINVING QUARTERS UPDATE

Fire Chief Nathan Bower explained that the two occupants have given a 30 day notice. Their last day will be August 15, 2015. They will both remain on the fire department.

MISC BOARD OF ALDERMEN

On a motion by Cheryl Altis and seconded by Clint Hilliard it was approved to place on the agenda the boat dock discussion due to letter received by Dave Farnham. Motion carried with all members present voting aye.

Mayor informed the board that included in the board packets is a letter from Dave Farnham concerning the boat dock property. The letter states that he relinquishes the property back to the City of Forsyth.
